# ARTICLES OF ORGANIZATION B & B CONSTRUCTION, L.L.C. A FLORIDA LIMITED LIABILITY COMPANY

#### ARTICLE 1: NAME

The name of the Limited Liability Company ("LLC") shall be B & B CONSTRUCTION, L.L.C.

#### **ARTICLE 2: PURPOSE**

The LLC may engage in any lawful business not prohibited by statute or law.

#### ARTICLE 3: REGISTERED AGENT

#### **ARTICLE 11: CERTIFICATES**

The LC has the authority and shall issue Certificates of Membership to each Member evidencing that Member's interest in the LLC. Certificates of Membership shall be signed by a Manager (or officer) of the LLC.

#### ARTICLE 12: TRANSFERABILITY OF MEMBER'S INTEREST

An interest of a Member of the LLC may be transferred to such extent and in the manner provided in the Operating Agreement. However, if all of the remaining Members of the LLC do not approve of such proposed transfer or assignment by unanimous written consent, the transferee of the interest of such member shall have no right to participate in the management of he business and affairs of the LLC or to become a Member. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferor Member otherwise would be entitled.
