**ARTICLES OF ORGANIZATION
OF
SWEETWATER PROPERTIES, L.L.C.**

The undersigned, pursuant to the Florida Limited Liability Company Act, does hereby make, acknowledge, and file the following Articles of Organization:

ARTICLE I

The name of the Limited Liability Company shall be:

Sweetwater Properties, L.L.C.

ARTICLE II

The principle office of this company shall be 311 Altamonte Commerce Blvd., Suite 1612, Altamonte Springs, Florida 32714, but this company may establish such other offices and branch offices within or without the State of Florida as may be necessary.

ARTICLE III

The company shall commence its existence on the date that these Articles of Organization are filed with the Florida Department of State. The company shall have perpetual existence, unless terminated as provided in Article IV hereof.

ARTICLE IV

The company shall be dissolved upon the unanimous agreement of all members or as otherwise provided by law.

ARTICLE V

The company is to be a manager-managed company. The company shall be managed by one chief executive manager, who is not a member of the company. The members shall hold the exclusive voting interest in the company and the exclusive power to adopt, alter, or repeal the regulations of the company. The members shall select the chief executive manager who shall serve at the pleasure of the members.

ARTICLE VI

The members of the company may enter into an operating agreement to provide for the operation of the company and other matters concerning the relative rights and obligations of the members; provided, however, that said operating agreement may not contravene these articles or the Florida Limited Liability Company act.


