



ARTICLE SIX - ADMISSION OF NEW MEMBERS


Upon the consent of the Managing Member, new members may be admitted and be issued some or all of the ownership interest held by the member. New members may only be added upon the written consent of the Managing Member. Consent of the Managing Member is also required regarding the management rights of any new members.

ARTICLE SEVEN - RIGHT TO CONTINUE BUSINESS

The inability of a non-managing member to continue his/her membership due to death, retirement, resignation or any other reason shall not impair the ability of Homemade, LLC, to continue in business.

ARTICLE EIGHT - DISTRIBUTION OF PROFITS/LOSSES

The profits and/or losses of Homemade, LLC, must not necessarily be distributed at any regular interval. It is only upon the agreement of the Managing Member that profits or losses will be distributed. Such profits or losses are to be allocated on the basis of the member's ownership share.
