ARTICLES OF ORGANIZATION

FOR

The undersigned, as the organizing Member of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "AR"), A hereby form a Florida Limited Liability Company (the "Company") pursuant to the Act, 22 and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I

Name

The Name of the Company is JN, L.L.C.

ARTICLE II

Commencement Date and Duration

The Company's existence shall commence on the date these Articles are filed with the Florida Department of State, and shall continue perpetually unless dissolved in accordance with Section 608.441 of the Act.

(b) <u>Title.</u> The title to all property of the Company shall be held in the name of the Company.

The Managers are hereby authorized to convey and

encumber title to all real and personal property of the Company, borrow money or obtain other credit or financial accommodations for the Company, create security interests in any property of the Company, and to otherwise deal with the assets and property of the Company in any manner which the Managers deem appropriate, subject to the limitations set forth in the Regulations.

Amendments

These Articles may be amended or restated at any time by the unanimous vote of the Members, and such amendment or restatement shall be filed with the Florida Department of State in accordance with the provisions of Section 608.411 of the Act.

ARTICLE XII

Regulations

Regulations shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Regulations may conflict with the provisions of these Articles unless permitted herein. The power to adopt, alter, amend, or repeal the Regulations shall be set forth in the Regulations.
