**AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR  
THE ROOSEVELT MEDICAL CENTER, L.L.C.**

Pursuant to the provisions of Section 608.411(5), Florida Statutes (2001), Aurelio A. Muzaurieta, as managing member of The Roosevelt Medical Center, L.L.C. , hereby amends and restates in their entirety those certain Articles of Organization of The Roosevelt Medical Center, L.L.C. dated May 23, 2002 (the "Prior Articles") to make such changes as agreed to by the current members of The Roosevelt Medical Center, L.L.C.
