1. Name. The name of the limited liability company is CR Investments of Florida, LLC.
2. Purpose. The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. Address of Principal and Registered Office. The address of the principal and registered office of the limited liability company is 1776 North Pine Island Road, Suite 326, Fort Lauderdale, Florida 33322.
4. Term. The term of this LLC shall be perpetual.
5. Members at Time of Formation. There will be two members at the time the limited liability company is formed: Milton L. Cruz and Aileen E. Rosso.


