ARTICLES OF ORGANIZATION

OF

ARTICLE 1

NAME



ARTICLE 6

No person may be admitted as an additional member without the prior written consent of the Manager. If such person is admitted, he or she shall be subject to the obligations and limitations in the Operating Agreement of the Company, as amended for the additional members.


