The name of the limited liability company is 888 RE FUNDING, LLC.

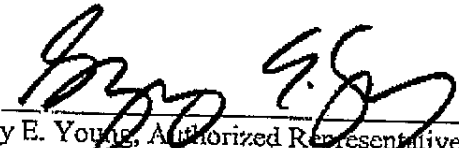

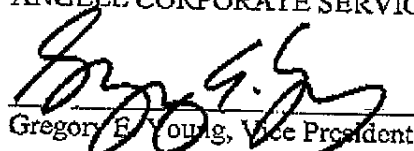
