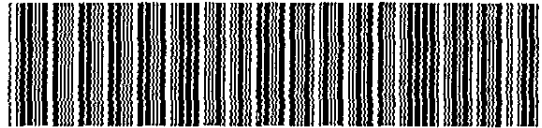

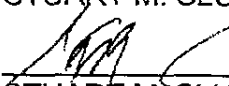

the financial interest of each member, shall consent in writing to the admission of additional members.

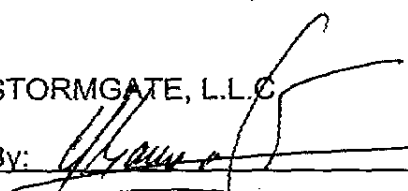
Article VI
