

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF SDE, LLC

(A Florida Limited Liability Company)

FIRST:

The date of filing of the Articles of Organization was May 28, 2002.

replaced with the following:

ARTICLE II ADDRESS
