The mailing address and street address of the principal office of the Limited Liability Company is 1901 South Tamiami Trail, Venice, Florida 34293.


ARTICLE III - Registered Agent and Registered Office

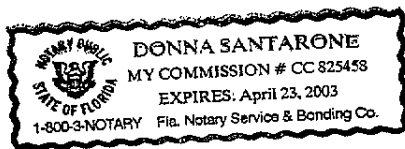




