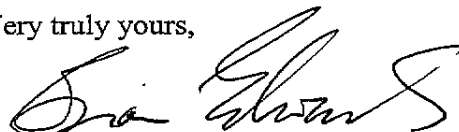

Company.

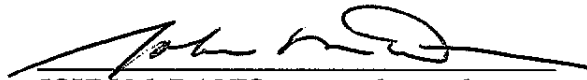

or other liability of the Company.

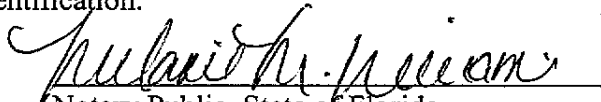
