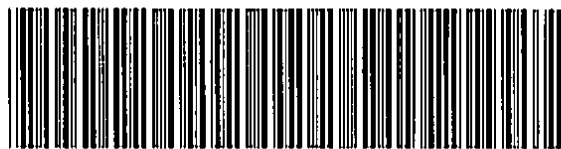

3. The following amendment to the Company's ARTICLES OF ORGANIZATION was adopted by the Company:

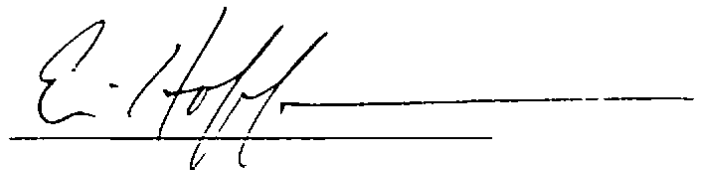
