

Articles of Organization

of

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

1. **NAME**. The name of this limited liability company (the "Company") is **ARGOS, LLC**.
2. **DURATION**. The period of duration of the Company shall be perpetual.
3. **PURPOSE**. The purpose and business of the Company shall be to engage in any lawful act or activity which may be carried on by a limited liability company under the Act.
4. **MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE**. The mailing address and street address of the principal office of the Company is: 620 Hibiscus Drive, Venice, Florida 34285.
5. **REGISTERED AGENT**. The name and address of the initial Registered Agent of the Company is: WAYNE C. HALL, ESQUIRE, 1314 East Venice Avenue, Suite E, Venice, Florida 34292.
6. **MANAGEMENT BY MANAGER**. The Members of the Company shall not be Managers by virtue of their status as Members. The Company shall be a manager-managed limited liability company and shall be managed by a Manager appointed by the vote of a majority in interest of the Members. The name and address of the initial Manager who shall manage the Company is PHILIP TSOLAKIS, 620 Hibiscus Drive, Venice, Florida 34285.
7. **ADDITIONAL MEMBERS**. New Members may be admitted only upon the unanimous written consent of the Members and in accordance with restrictions set forth in the Operating Agreement of the Company.
8. **LIMITED LIABILITY**. No Member or Manager or agent of the Company shall be liable under a judgment or decree, or order of a court, or in any other manner for any debt, obligation, or liability of the Company.
9. **CONTINUATION OF BUSINESS**. The remaining Members may, by unanimous agreement, elect to continue the business of the Company upon the death, retirement, resignation,

expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company. No Member shall be entitled to receive a return of capital or other distribution upon withdrawal from this limited liability company or otherwise, except as otherwise provided in the Operating Agreement of the Company.
