**ARTICLES OF ORGANIZATION
OF
HOPKINS FAMILY LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be HOPKINS FAMILY LLC ("Company").

The undersigned member has executed these Articles of Organization at Sarasota, Florida, on this 22nd day of May, 2002.




