ARTICLES OF ORGANIZATION OF WILSON SOUTH, LLC

The undersigned, being the sole initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

ARTICLE I NAME

The name of the limited liability company (the "Company") is WILSON SQUTH, LLC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall be 3550 Westview Drive, Unit #104, Naples, Florida 34104.

ARTICLE III REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered agent of the Company is 3550 Westview Drive, Unit #104, Naples, Florida 34104, and the name of the initial registered agent at such address is Brian Michael Wilson.

ARTICLE IV ADMISSION OF MEMBERS

The members of the Company may admit new members to the Company as more fully described in and subject to the terms, conditions and requirements set forth in the Company's Operating Agreement and Regulations. Newly admitted members shall have all of the rights and privileges as set forth in the Company's Operating Agreement and Regulations.

ARTICLE V EFFECTIVE DATE

The Company's effective date of existence shall begin on the date of filing of these Articles.

ARTICLE VI DURATION

The Company's duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members shall have the right to to continue the business of the Company as provided in the Operating Agreement and Regulations.

ARTICLE VII ADOPTION OF OPERATING AGREEMENT AND REGULATIONS

The initial Operating Agreement and Regulations of the Company shall be adopted by its initial members. The Operating Agreement and Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the Articles of Organization.

ARTICLE VIII INITIAL MANAGER(S)

The Company will be managed by one or more manager or managers, who shall be a member(s), and shall be designated, appointed or elected as more fully described in the Operating Agreement and Regulations. The Company, and is therefore a manager-managed company. The initial number of manager members of the Company is one (1). The number of manager members may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations.
