These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I - Name**

The name of the limited liability company is PRESENCE, LLC ("Company").

**ARTICLE II - Duration**

The Company shall exist from the date of filing these Articles with the Department of State until terminated in accordance with the regulations and/or in accordance with the law.

**ARTICLE III - Address**

The mailing and street address for the principal office of the Company is 809 Gay Street, Tallahassee, Florida 32302.

**ARTICLE IV - Admission of Additional Members**

Additional members to the Company may be admitted, but only if all the current members unanimously agree to the admission of the additional members and to the terms of admission.

**ARTICLE V - Members Rights to Continue Business**

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

#### **ARTICLE VI - Management**

The daily, usual course of business of the Company will be managed by a manager (the "Manager"). The Manager shall be elected annually by the members in the manner prescribed by and provided for by the members of the Company. The members reserve the general management of the Company to themselves, and therefore all decisions outside the usual course of the Company's business will require a vote of the members holding two-thirds interest in the Company. #### **ARTICLE VII - Operating Agreement**

The members shall have the power to adopt, alter, amend, or repeal operating agreements of the Company containing provisions for the regulation and management of the affairs of the Company.

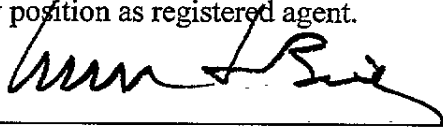
