**ARTICLES OF ORGANIZATION**  
**OF**

Pursuant to the Florida Limited Liability Companies Act, the undersigned hereby adopts the following Articles of Organization.

**I.**

**NAME**

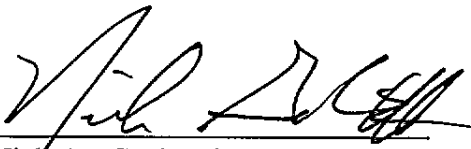

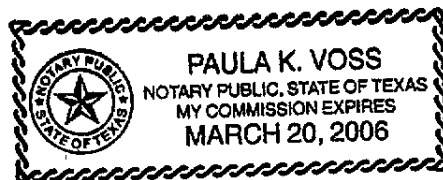
