

The name of this limited liability company is The Immigration and Tax Law Center, LLC.

This limited liability company shall not have more than fifteen (15) Members unless it is unanimously approved by the Members and reflected in the Bylaws.


ARTICLE VI - PRE-EMPTIVE RIGHTS
