

**ARTICLES OF ORGANIZATION
OF
SOLUTIONS BRIDAL & FORMAL WEAR, L.C.**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is SOLUTIONS BRIDAL & FORMAL WEAR, L.C. (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The Company shall terminate on May 22, 2052.

**ARTICLE III
REGISTERED OFFICE AND AGENT**




**ARTICLE VII




