ARTICLES OF ORGANIZATION
FOR
WEBBER MARINE, LLC

ARTICLE I - Name

The name of this limited liability company shall be WEBBER MARINE, LLC.

ARTICLE II - Duration

The limited liability company shall have a perpetual existence.

ARTICLE III - Purpose and Powers

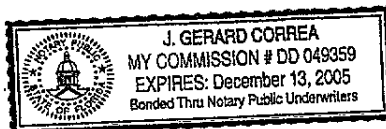
