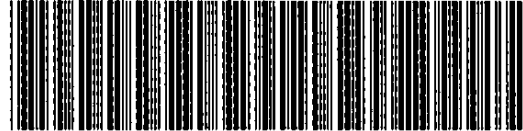

ARTICLES OF DISSOLUTION

Pursuant to Florida Statute §608.445, **SOUTH-EAST SUPPLIES, LLC** submits the following Articles of Dissolution:

FIRST

The name of the corporation is: South-East Supplies, LLC.

SECOND

The effective date of South-East Supplies LLC's dissolution is the 6th day of JUNE, 2006.

THIRD

Both members/managers of South-East Supplies, LLC hereby resign their membership in the company. Thus South-East Supplies, LLC is hereby dissolved pursuant to Article 8 of the company's Article of Organization which states, among other things that "the company shall be dissolved upon the . . . resignation . . . of a member in the company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least one remaining member." Since both members of the company have resigned, South-East Supplies, LLC ceases to exist.
