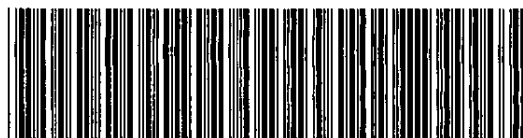


Enclosed please find the filing for the dissolution of Roothold LLC, document number L02000013329. The reason for the dissolution is that there has been no activity for several years.
