ARTICLES OF ORGANIZATION OF PJM, LIMITED LIABILITY COMPANY(L.L.C.)

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be PJM, LLC ("company")

ARTICLE II -- ADDRESS

ARTICLE III -- DURATION
