ARTICLE VII - Members' Rights to Continue Business:

The right, if given, of the remaining member(s) of the limited liability company to the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of another or the occurrence of any other event which terminates the continued membership of a member this limited liability company shall be:

The remaining member(s) of the company have the right to continue the business of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company only upon the vote of a majority in interest of the remaining members.
