Articles of Organization

of

Grand Bimini, LLC

Pursuant to the provisions of Section 608.407, Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of **Grand Bimini, LLC**, a Florida limited liability company (the "Company"):

1. **Name**. The name of the Company is **Grand Bimini, LLC**.

2. **Duration**. The Company shall exist perpetually.

3. **Purpose**. The company is organized to engage in and to do any lawful act concerning any and all lawful business, other than banking or insurance, for which a limited liability company may be organized.

4. **Principal Office**. The mailing address and street address of the initial principal office is 626 Boca Ciega Isle Dr., St. Petersburg Beach, FL 33706.

5. **Registered Agent**. The name of the initial registered agent is **Ramses S. Nashed**, whose business address is the same as that of the principal office.

7. **Management; Initial Members**. The Company is to be managed by one or more Managers and is, therefore, a managermanaged company. The number of Managers may either be increased or decreased from time to time by agreement of the Members but shall never be less than one. The name of the initial Manager is **Ramses S. Nashed**.

8. **Written Operating Agreement**. Any operating agreement must be in writing.

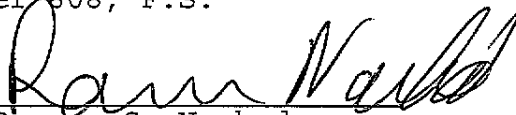
