SECOND AMENDMENT TO OPERATING AGREEMENT FOR LAKE OKEECHOBEE REDEVELOPMENT, LLC

ASSIGNMENT OF MEMBERSHIP INTEREST



This Second Amendment to Operating Agreement for Lake Okeechobee Redevelopment, LLC (hereinafter "the LLC") is made and entered into this 1st day of July, 2008, by and between all members of the LLC who have affixed their signature hereto as of this date.

1. Amendment to Agreement.

a. Section 2.1 of the Original Operating Agreement is hereby amended in its entirety to read as follows:

Section 2.1 Members. The name, initial capital contribution, Ownership Percentage of the Members are set forth in the below table, which shall be amended from time to time to reflect the admission of new Members.
