ARTICLE III - MANAGEMENT


The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager - managed company. The initial manager is Donald C. Nestor.

AND REGISTERED AGENT'S SIGNATURE

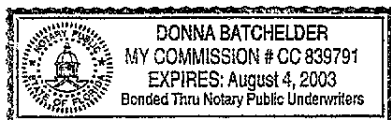


