**ARTICLES OF ORGANIZATION
OF
BWS, L.L.C.**

The undersigned hereby form and establish a limited liability company pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE I

The name of this limited liability company is **BWS, L.L.C.**

ARTICLE II

This limited liability company shall have an existence commencing five (5) days prior to the date of filing these Articles with the Florida Department of State and continuing perpetually, unless sooner terminated as provided in any Operating Agreement for the Company.


