ARTICLES OF ORGANIZATION OF BWS, L.L.C.

The undersigned hereby form and establish a limited liability company pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE I

The name of this limited liability company is BWS, L.L.C.
