Pursuant to section 608.4115, Florida Statutes, this document is being submitted within the required 30 business days to correct the attached articles of organization.

First: The name of the limited liability company is AMERICAN HOUSING COMPANY, L.L.C.

Third: The Articles of Organization contains incorrect statements. The incorrect statements, the reason the statements are incorrect and the corrected statements are as follows:

1. Article IV incorrectly fails to identify Ecufund, Inc. as a member. Article IV also incorrectly identifies Harvey Burton as a managing member. Harvey Burton is not a managing member or a member. Ecufund, Inc. is a member. The corrected Article IV is as follows:


