ARTICLES OF ORGANIZATION OF PANDE PANE, LLC

ARTICLE I Name

The name of the limited liability company is Pande Pane, LLC ("Company").

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the members.
