MEMBERSHIP RESTRICTIONS

ARTICLE VII

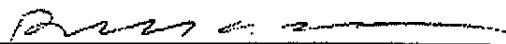

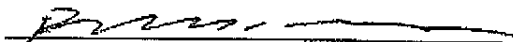
