ARTICLES OF ORGANIZATION



The undersigned, for the purpose of forming a limited liability company under the Florida, Limited Liability Company Act, F.S. Chapter 608,407, hereby make, acknowledge, and file the following Articles of Organization for DEA02, LLC.


