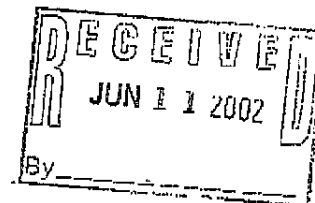

**ARTICLES OF ORGANIZATION OF

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be Pies and Plates, LLC, and the mailing address and street address of its principal office shall be 224 Freeport Court, Punta Gorda, FL 33950, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II
