**ARTICLES OF ORGANIZATION OF
PHYSICIAN NEWS NETWORK, L.L.C.**

The undersigned, acting as the organizer and authorized representative, for the purpose of formation of a Limited Liability Company under the Florida Limited Liability Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I.
NAME**

The name of this Limited Liability Company shall be **PHYSICIAN NEWS NETWORK, L.L.C.**

**ARTICLE II.
PLACE OF BUSINESS AND REGISTERED AGENT**
