ARTICLES OF ORGANIZATION OF BUDGEN & WILLIS, P.L.

Article I- The name of the Professional Limited Liability Company is the following: Budgen & Willis, P.L.

Article II- Purpose of the Professional Limited Liability Company and the scope of its powers.
