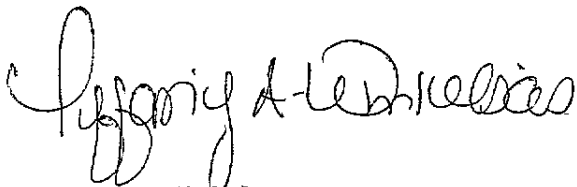

**ARTICLES OF ORGANIZATION  
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company will be NEASE, LLC ("company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company is 1601 Jackson Street, Suite 202, Fort Myers, Florida 33901.

**ARTICLE III -- DURATION**

The company will commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified. The company's existence will be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the company in the state of Florida is Stephen Nease, 1601 Jackson Street, Suite 202, Fort Myers, Florida 33901.

**ARTICLE V -- CAPITAL CONTRIBUTIONS**

The members of the company will each contribute to the capital of the company \$1,000 as their respective capital contribution.

**ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member will make additional capital contributions to the company only on the unanimous consent of all the members or as provided in the regulations.

**ARTICLE VII -- ADMISSION OF NEW MEMBERS**

Except as set forth in the regulations, no additional members will be admitted to the company except with the unanimous written consent of all the members of the company and on the terms and conditions as determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee will have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company will be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by majority vote of the remaining members.
