SECOND AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF BHCRE I, L.L.C.

The undersigned, Frank B. Burge, a natural person competent to contract and members of BHCRE I, L.L.C., a Florida limited liability company (the "Company"), hereby presents these Second Amended and Restated Articles of Organization (these "Articles") pursuant to the provisions of Section 605.0202, Florida Statutes. These Articles have been duly adopted by the members of the Company and shall be effective as of the date these Articles are filed with the Florida Department of State.
