ARTICLES OF ORGANIZATION
OF
Sarah Holdings, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, at Chapter 608, Florida statutes, hereby makes, acknowledges, and files, the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Sarah Holdings, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is Post Office Box 6067, Palm Harbor, Florida 34684 (mailing address); and 1942 Lago Vista Boulevard, Palm Harbor, Florida 34685 (street address).

ARTICLE III -- DURATION



ARTICLE V -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the operating agreement of the company, but the transferee shall have no right to participate in the management of the

business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VI -- MANAGEMENT

The company shall be managed by the members in accordance with the operating agreement adopted by the members for the management of the business and affairs of the company. The operating agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
