Any amendment to the Articles of Organization shall be approved by all the members and shall be as prescribed by the Secretary of State of the State of Florida.

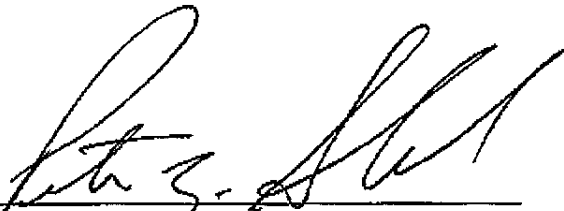

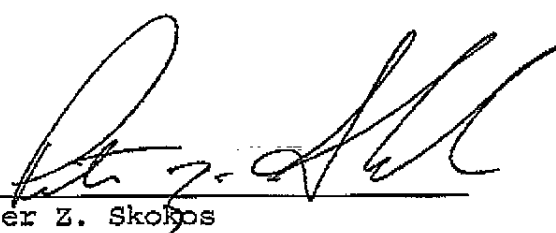
ACCEPTANCE OF REGISTERED AGENT
