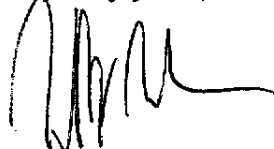

NAME**

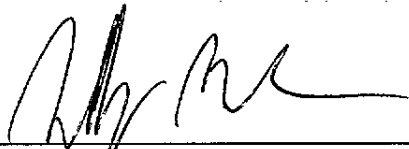
