We recently learned that the above entity has been listed as inactive for failure to file its 2003 Limited Liability Company Uniform Business Report. My colleague Bruce Pender mailed the original UBR signed by me to your office on April 26, 2003, together with our check #1093 in the amount of \$55.00 to cover the filing fee, which was cashed and deposited at the time the report was filed. By letter of October 22 to your department, Bruce forwarded copies of the UBR and cancelled check showing the annual fee was deposited by you on April 28.

Our attorneys have advised us that they determined from one of the employees in your department that the UBR was received by you, but was returned to us on May 19, 2003, requesting us to include an FEI number.
