ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

The undersigned organizer and representative, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

ARTICLE I - Name

The name of the limited liability company created hereby (hereinafter, "the Company") is: Goodyear Belting, LLC

ARTICLE II - Purpose

The Company's business activities shall include, but not be limited to, the purchase and sale of automobiles in the State of Florida. - (l) Make payments or donations or do any other act not inconsistent with law the furthers the business of the Company.
