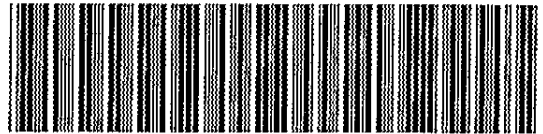


Subject: Dissolution of "T.R.Jackson Ventures, LLC"
