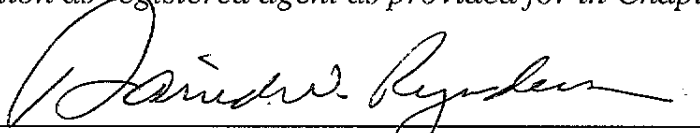

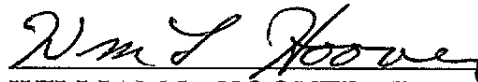
The Limited Liability Company is to be managed by one manager and is, therefore, a manager - managed company.
