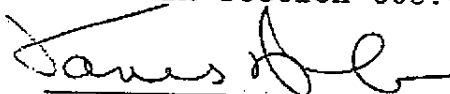
ARTICLE II - ADDRESS

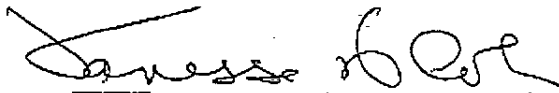
