Additional members may be admitted to the limited liability company upon the unanimous agreement of all members of the limited liability company.



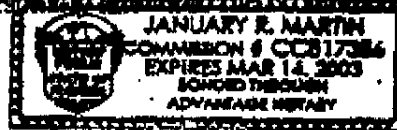
