**ARTICLES OF ORGANIZATION OF
JOCELYN E. LEVEQUE, M.D., P.L.**

The undersigned, JOCELYN E. LEVEQUE, M.D., a natural person competent to contract, and licensed to render services as a doctor of medicine under the laws of the State of Florida, hereby presents these Articles of Organization as the Articles of Organization of Jocelyn E. Leveque, M.D. P.L. for the formation of a professional limited liability company under the provisions of Chapter 627 and 608, Florida Statutes.

ARTICLE I - NAME

The name of the professional limited liability company is:

JOCELYN E. LEVEQUE, M.D., P.L.

This professional limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the principal office of the Company is 1391 Players Club Court, Gulf Breeze, Florida 32563.

ARTICLE III - PURPOSES AND POWERS

This Company is organized to engage in every phase and aspect of the business of rendering professional services that a physician duly licensed under the laws of the State of Florida to practice medicine is authorized to render, but such professional services shall be rendered only through its members, offices, employees, and agents who are duly licensed under the laws of the State of Florida to practice medicine therein, and for any other legal and lawful purpose for which a professional limited liability company may be organized under the Florida Limited Liability Act.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of the Organization are filed with the Secretary of State of Florida. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT

The address of the registered office of the Company is 1391 Players Club Court, Gulf Breeze, Florida 32563, and the name of the registered agent at that address is Jocelyn E. Leveque, M.D.

ARTICLE VI - MANAGEMENT

The Company shall be managed by its members in accordance with the provisions of its Operating Agreement. The name and address of the initial member is as follows:

ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS

The initial member of the Company is Jocelyn E. Leveque, M.D. New members shall be admitted to the Company only upon the agreement of all of the members or as otherwise provided in the Operating Agreement of the Company.

ARTICLE VIII - RESTRICTION ON MEMBERSHIP

A member may not sell or otherwise transfer his or her Membership Units until the member has complied with the restrictions, including a right of first offer and a right of first refusal, contained in the Operating Agreement for the Company.
