

LEVEQUE, M.D., a natural person competent to contract, and licensed to render services as a doctor of medicine under the laws of the State of Florida thereby presents these Articles of Organization as the Articles of Organization of Jocelyn E. Leveque P.L. for the formation of a professional limited liability company under the provisions of Chapters 62 B. and 608, Florida Statutes.

ARTICLE I - NAME

The name of the professional limited liability company is:
